

# Wholesale Agreement

## GENERAL TERMS OF AGREEMENT

To qualify for wholesale purchases, you must be a valid retail business. By agreeing to our terms and conditions you certify that you are such. You are only authorized to sell through the retail store that you have listed. Secondary stores, as well as website and online sales must receive prior written approval.

## ORDER REQUIREMENTS

We require that you purchase a minimum of \$150 on each order.

Due to high demands for Christmas and Easter seasons, all orders for this specific period must be placed 60 days before the holiday. We can't guarantee our usual delivery time if an order is submitted after this deadline.

## PAYMENT INFORMATION

We accept payments via credit card, and checks.

Orders must be pre-paid or you must be approved by Catholic Concepts for payment terms (on request) We reserve the right to alter our prices at any time unless you have a current invoice. SHIPPING & HANDLING

The retailer incurs the shipping costs but Catholic Concepts will insure packages with the carrier. Delivery is typically within 3 to 7 business days but could take up to three weeks. We use USPS or UPS Ground shipping, based on cost affordability, If your shipment is damaged in transit you agree to contact Catholic Concepts within 3 days of delivery.

Any problems must be reported in writing or by email and retailer cannot return goods until he/she has received a written authorization. Goods sent back without one will not be credited to your account.

## MINIMUM ADVERTISED PRICE POLICY

The Catholic Concepts Minimum Advertised Price (MAP) policy has been established in order to protect the investment our retail partners have made and the reputation of our brands. Catholic Concepts encourages retailers to sell our brands in their store, as well as on the internet (upon approval), provided that the retailer respects the MAP policy. Catholic Concepts is

confident that this policy will benefit all retailers while strengthening the reputation of our brands.

Catholic Concepts requires that retailers advertise our products at or above the established MAP for each item. The established MAP standard shall be double Catholic Concepts' wholesale price, minus \$0.01. Catholic Concepts' wholesale price can be found online at [CatholicConcepts.shop](http://CatholicConcepts.shop). All products displayed or listed must have the appropriate MAP. If a price other than the MAP for that respective item is listed, that will be considered a violation of this policy.

The MAP policy does not pertain to free or discounted shipping, which may be offered to your consumers at your discretion. These and other special offers are permitted as long as MAP remains intact on the shelf displays or online product pages. "Bundled" products must be sold for the sum of the MAP of the items included in the bundle.

Failure to comply with Catholic Concepts' MAP policy will result in the following actions:

- First violation: A warning is issued. Customers will be given until the next day to bring pricing back to MAP. Orders for products from Catholic Concepts will be held until the violations are corrected.
- Second violation: Shipments from Catholic Concepts will be suspended for the remainder of the calendar year.
- Reinstatement: Shipping to two-time MAP violators will be at the discretion of Catholic Concepts, and will occur no sooner than January 1 of the following calendar year.

This policy does not authorize the sale of products on third-party internet sites/marketplaces as that does not allow Catholic Concepts to properly manage this MAP policy and the integrity of our brands. Third-party internet sites are not authorized to offer our brands. Selling Catholic Concepts' products on 3rd party sites is prohibited and customers are subject to the same actions as violating MAP pricing.

By purchasing product, you are acknowledging the information in this MAP policy and agreeing to its adherence.
